

## PRIVACY STATEMENT

### **Personal Data elements collected/processed:**

- Family member/Guardian details such as Name, Signature.
- Contact Information - Email, Contact Number, City, Country.
- Education details- Institution, Grade, Board.

### **Purpose of Processing**

Infosys Ltd. and ISF may hereinafter be required to collect, receive, possess, store, deal or handle your Personal Data for the following Purposes:

- To enable your child/ward to apply and register for to be a part of ‘The Science Society’ initiative by Infosys Science Foundation.
- To identify and shortlist eligible candidates for The Science Society.
- For sharing correspondences with your child/ward, if they are selected to The Science Society, for the purpose of sending their contributions, interacting with their peers etc.
- For audits and reporting purposes.
- For complying with any legal obligations on us, including any applicable laws and protecting our legal rights, seeking remedies, and defending against claims.

### **Data Recipients**

You hereby understand that the following recipients shall be collecting and retaining Your Personal Data:

- Internal departments within Infosys: Authorized members of functions such as Infosys Science Foundation team, Marketing Team etc.
- Auditors (Internal/External) and Authorities.

**Data transfer and Storage:** If necessary for the above stated purpose, the Personal Data listed above may be transferred to our offices, and such data will be stored on our authorized cloud service providers’ servers in US and Europe.

### **Security Measures**

Infosys Ltd. and ISF adopts reasonable and appropriate security practices and procedures including administrative, physical security, and technical controls in order to safeguard your Personal Data.

### **Retention Period**

Personal Data will not be retained for a period more than necessary to fulfill the purposes outlined in this Privacy Statement, unless a longer retention period is required by law or for directly related legitimate business purposes.
